PURPOSE

Our Vision is that all liver cancer patients are diagnosed in time, are treated with respect and have equal access to the best standard of medical care, regardless of origin, lifestyle and type of liver cancer. Our ultimate goal is a world without liver cancer related deaths.

ABOUT

The International **Liver Cancer Movement (ILCM)** is the first ever global movement bringing together patient groups, scientific associations, public health institutions, private sector entities as well as non-associated individuals representing a community (e.g. bloggers, influencers) to:

- Work together in a spirit of trust, mutual respect, inclusiveness and co-operation to build and drive a strong global Liver Cancer Community
- Share resources, experiences and knowledge
- Co-create meaningful and impactful outputs for people living with or at risk of developing liver cancer, via the movement's different workstreams.

Since its inception in the beginning of 2021, the ILCM has already impacted the liver cancer field, achieving **very important milestones on global, regional and national levels** such as:

The ILCM is not an incorporated entity but a **global movement**, whose treasury is provided by Kautz⁵ gUG, Cologne, Germany under the German non-profit tax law.

The work of the ILCM is currently divided into **three priority areas** (workstreams):

- The Workstream **AWARENESS**: co-creation and dissemination of tools about diagnosis and treatment of liver cancer (incl. global campaigns)
- The Workstream **POLICY**: evidence to support advocacy efforts (e.g. consensus statements, surveys, etc)
- The Workstream **DIGITAL TOOLS**: Prevention, diagnosis, disease management, treatment of Liver Cancer

The workstreams provide an excellent opportunity to generate impactful discussions leading to the co-creation of solutions/projects which set liver cancer on global agendas while boosting national efforts.
